## 簡歷:

林建志是中研院法律所研究員以及國立臺灣大學國家發展研究所合聘副教授。畢業於芝加哥大學法學院,他的研究興趣包括比較憲法、憲法、司法行為、司法政治。他是 Constitutional Convergence in East Asia 和 Ultimate Economic Conflict between China and Democratic Countries 兩本書的共同作者,論文並發表在包括 American Journal of Comparative Law 和 International Journal of Constitutional Law 等重要期刊上。他是 International Journal of Constitutional Law 的書評編輯。

Chien-Chih Lin is a research professor at Institutum Iurisprudentiae, Academia Sinica and an associate professor at the Graduate Institute of National Development, National Taiwan University. His academic interests focus on comparative constitutional law in Asia. Lin is the coauthor of Constitutional Convergence in East Asia and Ultimate Economic Conflict between China and Democratic Countries. His articles can be found in both peer-reviewed and student-edited law journals, as well as edited volumes, including Oxford Handbook of Constitutional Law in Asia, American Journal of Comparative Law, and International Journal of Constitutional Law. He is the book review editor of International Journal of Constitutional Law.

# 代表作簡介:

區域研究在許多領域都越來越重要,比較憲法也不例外,而亞洲的憲 政發展,便是比較憲法的重點領域之一。目前國際主流的憲政理論,追根 究柢仍植基於西方國家,特別是美國與西歐國家的憲政發展與文化,雖然 有不少西方學者也意識到這個問題,但他們對於亞洲的憲政發展不夠了解,因此雖然意識到問題,但卻無法解決。申請人的研究成果,將可能成為反省、修正傳統憲政理論的起點。簡言之,申請人的研究方法,就是在探討所謂亞洲憲政主義的可能性,對於國際比較憲法學術界,在了解亞洲的憲政發展時,將成為重要的參考文獻。

Regional studies have become increasingly important in many fields, and comparative constitutional law is no exception. The mainstream constitutional theories, however, have predicated on Western experiences, particularly those in the United States and Western Europe. Although many scholars are aware of this problem, they cannot solve it because they do not understand constitutional development in Asia enough. The research results of my studies could be used to reflect and refine mainstream constitutional theories, shedding new light on the discussion of Asian constitutionalism.
